**2025 PREA Annual Report**

**Dates: 9-1-2024 through 8-31-2025**

The completed report is pursuant to the Prison Rape Elimination Act (PREA) standard 115.287-data collection and 115.288-data review for corrective action.

Amarillo TTC (facility) provides incident-based data and aggregated PREA data to the contracting agency per PREA standard 115.287. Upon request, the contracting agency provides all PREA data from the previous calendar year to the Department of Justice (DOJ). The DOJ utilizes a standardized instrument; the Survey of Sexual Victimization (SSV) for collecting data from criminal justice agencies.

The facility collects and maintains accurate uniform data for every allegation of sexual abuse and sexual harassment at the Amarillo Transitional Treatment Center, Inc. utilizing the most recent SSV instrument. This will ensure the facility is able to supply the contracting agency with data the DOJ will request. The PREA Coordinator notes the prescribed data from each incident on the SSV (section II, and III) at the conclusion of each incident. At the beginning of each year, (September) the PREA Coordinator completes the required PREA annual report for the previous calendar year using aggregated incident based PREA from the SSV.

The PREA annual report is reviewed and approved by the Chief Executive Officer, Program Director - PREA Coordinator.

In addition to the PREA data, pursuant to PREA standard 115.288, the facility annual PREA report also includes any corrective action the facility has taken up to the time of report to improve the effective of sexual abuse prevention, detection, and response policies, practices, and training, to include:

- Identification of problem areas.
- Corrective action taken on an on-going basis; as a result of incident investigations.
- A comparison of the current year's data and corrective actions with those of prior years (if applicable).
- Provide an assessment of the agencies progress in addressing sexual abuse.

The facility continues to place client rights, their health, safety, and welfare at the front (first) of managing people under our care and taking a serious stance of preventing sexual abuse and harassment with this population as we provide service delivery.

In response to last year's data, we see the same areas reported of unsubstantiated or unfounded incidents where there is more awareness of what constitutes sexual harassment and abuse. As a result, staff is monitoring more closely to prevent sexual harassment and sexual abuse. The agency has developed a PREA culture and corrective action is taken immediately in all cases reported.

A PREA culture for awareness has been established with patients and staff.

Based on the reported incidents for FY 2025, a corrective action plan is not indicated as the agency had zero (0) PREA incidents. No problem areas identified at this time.
